I also acknowledge and agree as a condition of entry that neither the Australian Auto-Sport Alliance Inc nor the promoters, nor the AMRS, nor the sponsor organisations, nor the land owners or lessees, nor the organisers of the racing event, nor their respective servants, officials, representatives or agents (all of whom shall collectively be called "the Organisers"), shall be under any liability for my death, or any bodily injury, loss or damage which may be sustained or incurred by me as a result of participation in or being present at the event, except in regard to any rights I may have arising under the Trade Practices Act 1974.
